

Operation Rosepool

OPERATION ROSEPOOL kicks off to an impressive start....

Over the weekend of 8th August, officers from North Warwickshire SNT, Staffordshire Police and West Midlands Police came together to tackle the illegal use of off-road bikes and nuisance bikes in our towns and villages.



The results included:

- 5 warrants completed
- 10 people were arrested
- 18 vehicles were seized
- 1 vehicle was recovered seven hours after being stolen.
- 1 motorbike was found seven minutes after being stolen
- 1 bike seized which was involved in drug supply
- 2 E-bikes that were not road legal seized

PCSO Demi Smith said: "We know how concerned people are about nuisance bikes and we will continue to tackle the problem.

"You can provide information through the Dob Em In reporting system (link in he comments below) or by contacting us directly.

"Future operations are planned and the information you provide will help us target these."

OP PLENTY

#OpPlenty has now launched in Atherstone, Coleshill and the surrounding villages.

The scheme was already running in Nuneaton and Bedworth, and since last year, there were 35 people visited as a result of Op Plenty.

Op Plenty involves our Safer Neighbourhood Team officers dropping by the homes of vulnerable people in our community for a cup of tea and a chat to check whether they are OK and if there's any further support that can be provided.

Inspector Andi Gibbons of North Warwickshire Safer Neighbourhood Team said "We're very happy to announce our support of Op Plenty in Atherstone and the surrounding villages. "We are in quite a rural part of the county, and we're aware that this can sometimes make the loneliness of older people in particular who find travelling difficult more pronounced. "Op Plenty gives us a way of finding out where those who would appreciate us dropping by are, and a reason to check in."

OP ROSEPOOL - Off Road Bikes

OP ROSEPOOL - Illegal use of off-road bikes.

Due to the ongoing issues with off road bikes in North Warwickshire, North Warwickshire Safer Neighbourhood Team now have a dedicated operation for the illegal use of off-road bikes.

Operation Rosepool aims to tackle the illegal use of offroad bikes and nuisance bikes and the impacts they have on the communities in North Warwickshire.



The Off Road Team have been patrolling hotspot areas.

A Section 59 Warning Notice has been issued to a male who has been riding an off-road bike on the road in one of the villages. If we see him riding the bike again, it will be seized. Further off-road bike patrols will be conducted over the next couple months.

If you witness someone riding an off-road bike in an antisocial manner, please report them through the QR code below.



As many may have experienced within the local community, the rise in Anti-social behaviour involving a large number of motorbikes.

Most of these bikes are driven illegally without insurance and pose a danger to the community. Therefore, we need to encourage the community to inform of us of these concerns with as much information as possible so we can get these bikes off the streets and crushed.

We can also issue the driver a Section 59 which grants us the powers to seize and remove vehicles that are being used to cause alarm, distress or annoyance, careless or inconsiderate manner and off-road driving, this will last for 12 months. A section 59 also applies to both the driver and the vehicle so even if someone else drives the same vehicle in an anti-social manner, we can still enforce it.




Following reports of nuisance bikes over the weekend, we are committed in targeting the individuals that think it is acceptable to cause danger to other motorists and pedestrians with complete disregard for the law.

Under Operation Rosepool we will be proactively targeting offenders and seizing any vehicles used illegally.

OP CAR KEY BURGLARY - VEHICLE CRIME

PC 2300 Thompson & PC 1372 Breeze from Coleshill safer neighbourhood team have been out in Shustoke engaging with the local community regarding vehicle crime.



Officers walked around the village knocking doors offering local residents faraday pouches for their vehicle alongside giving out crime prevention advice in relation to vehicle crime.



We shall continue to get out into our local villages and towns in the coming weeks to engage with the local residents, offer crime prevention advice alongside handing out security benefitting items as we look to reduce vehicle crime and burglary in the areas.

PCSO Scott continued patrols around Ables Way and Carlyon Industrial Estate in Atherstone to deter commercial burglaries.


Great engagement with night staff and local businesses starting early.

Arrests and Outcomes

A man has been jailed for seven years for nonrecent sexual offences against three women.

In 2022, our Child Abuse, Trafficking and Exploitation Team launched an investigation into 67-year-old Graham Cockerill of Elwy Circle, Ash Green, Coventry.

Cockerill was reported to have sexually assaulted three women. The first victim, (then under 13), reported assaults by Cockerill taking place in the Coventry area between 2016 – 2022.

Another victim made themselves known to investigators and reported offences by Cockerill throughout the 1970s, between the ages of nine and 14, in the Meriden area.

Through the course of the investigation, a further victim was identified who was aged in her 40s at the time. She sadly passed away in 1995 and had never reported the offences to police.

In June, following a trial at Warwick Crown Court, Cockerill was found guilty of:

- Three counts of sexual assault on a girl under 13 by touching
- Two counts of indecent assault on a girl under the age of 14
- One count of indecent assault of a female over 16 years of age

On Tuesday last week (5 August), he was sentenced to seven years' imprisonment at Warwick Crown Court. He was also given a 10-year restraining order for one of the victims, a 15-year Sexual Harm Prevention Order (SHPO) and will also be on the Sex Offenders' Register for life.

Det Con James Manders, formerly of our CATE team, commented, "This case demonstrates that in certain circumstances, a victim need not necessarily even be alive for us to obtain a conviction.

"Despite 30 years having passed since her death, and having never reported the crime to the police, we worked tirelessly to gather evidence to ensure we could bring Cockerill to justice.

Thankfully, the Crown Prosecution Service (CPS) decided to progress with this case thanks to statements from living witnesses about the victim and the offender disclosing details of the crime to them. I'd like to thank the CPS lawyer who decided to authorise this charge and allow a jury to make up their minds about Cockerill's guilt.

"The victims and witnesses in this case are amongst the most extraordinary people I have had the pleasure of knowing during my policing career. They showed great strength and courage throughout the process. As always, the service we provide to victims will always be at the forefront of any investigation, whether living or deceased."

We hope this sentence reassures victims that police take reports of sexual offences seriously and will conduct full and thorough investigations into any reports made.

Community Speed Watch

E-Scooters

Electrical scooters (also known as e-scooters) come under the category of 'powered transporters'. This covers a range of personal transport devices that are powered by a motor.

E-scooters are classed as motor vehicles under the Road Traffic Act 1988. This means the rules that apply to motor vehicles, also apply to e-scooters including the need to have a licence and insurance. There are two ways of using an e-scooter:

- by privately owning one
- by renting one through an authorised rental scheme

It's not currently possible to get insurance for privately owned e-scooters. This means it's illegal to use them on the road or in public spaces, such as parks, street pavements, and shopping centres. If you use a privately-owned e-scooter in public, you risk the vehicle being seized under S.165 Road Traffic Act 1988 for having no insurance. If you cause serious harm to another person whilst riding an e-scooter, the incident will be investigated in the same way it would if you were riding a motorcycle or driving a car. Where you can use your own e-scooter: If you own an e-scooter, you can only use it in on private land, such as in a garden. But you must have the permission of the landowner to do so.

Vehicle Crime

Do you have a keyless entry vehicle?

Thieves can steal your keyless vehicle by hijacking and amplifying the signal from your start device (key) in order to start your vehicle.

Help to protect your vehicle by:

- Make sure your vehicle is properly locked/secure and keep your key away from doors and windows. This will reduce the chance of criminals amplifying the signal.
- Some keys have a function allowing them to be turned off. Check your manual to see if yours does and then use it.
- Use some kind of physical barrier such as a steering wheel lock (preferably a disk lock), instal a driving parking post or use a wheel clamp. This will deter many criminals as it will be time consuming for them to move the vehicle.
- Fit a tracking device into your vehicle.
- Keep your keys in a Faraday bag to block the signal to your keys.
- Remove batteries from your spare key or put them in a separate Faraday pouch.

And remember to be on the lookout for people acting suspiciously and report it by calling 999!

PCSO Mitchell and PCSO Smith have been out distributing faraday pouches.

These have been distributed around some of our high targeted areas. The pouches have very kindly been purchased by North Warwickshire Borough Council, in our steps to tackling vehicle crime.

We believe a joint approach is key when tackling crime. We have received lots of great comments from residents, many of whom we have been able to offer lots of crime prevention information to.

Initial police response to vehicle crime.

Initial call managed by either LPRC or control room and if the incident is live and ongoing seek immediate deployment.

During the initial contact, the call taker will provide reassurance and discuss all investigative opportunities such as CCTV, Witnesses, Forensic opportunities with the victim or witness.

These questions and responses will be documented on the Strom log and an investigation is then created.

Call taker will provide scene preservation advice to the victim

Should there be no investigative opportunities the investigation will be sent to the CCC to complete and record a review and ensure that all investigative opportunities have been considered.

At this stage a decision will be made to either file the investigation if there are no further opportunities to pursue a positive outcome or allocate to an officer with an action plan should further potential investigative opportunities exist to seek a positive outcome.
